- 2. The applicant was appointed in 2006 as Forest Guard in pursuance to the G.R. no. FTR-15/04/pra.kra.136/F-4, Mantralaya, Mumbai, dated 12/07/2004. It is claimed that as per Annex-10 vide letter no. kaksha/ashtha/353/2016-17, dated 6/12/2016, the applicant has been sent to the Medical Board without assigning any specific reason for that, therefore, the said order is to be illegal.
- 3. It is case of the department that the applicant was absent from duty unauthorizedly from 26th September,2013 and therefore, direction was given to the applicant to appear before the Medical Board and produce fitness certificate. It is submitted by the learned P.O. that there

is no illegality in it. We have perused the certificate issued by the Medical Board, Medical Board examined the the applicant and issued certificate which at Annex-A-11. On perusal of Annex-A-11 it seems that against column "fit for duty" earlier it was written 'Yes' thereafter 'No' and both the words scoured out and thereafter 'No' is written. therefore. this certificate apparently itself is suspicious.

- 4. It appears from the circumstances that the applicant was appointed in service with knowledge of his physical disability in the year 2006 and as per the Annex-A-10 the applicant was on duty till 26th September,2013. In view of this, the question would arise what was the propriety to refer the applicant to the Medical Board, because, it was not in contention of the respondents that the applicant had applied for leave on the ground of illness and therefore there was no reason to refer the applicant to the Medical Board.
- 5. The learned P.O. submitted that regarding absence of the applicant from duty for a period more than three years

departmental inquiry is in progress. this regard we would like to point out that the department has every right to take action against the applicant as he remained absent from the duty though his leave was not sanctioned, but in such circumstances it cannot be justified to refer the applicant to the Medical Board and call his fitness report from the Medical Board. Once it was accepted that the applicant was appointed in service with knowledge of his physical disability and which was the same even when the applicant was examined by the Medical Board, therefore, the action of the respondent i.e. Deputy Director of Pench Tiger Project, Nagpur cannot be justified at all.

6. We have perused the reply submitted by the respondent no.4 which is at page no.60 of the P.B. In para-3 of the reply it is specifically mentioned that the during course of the examination of the applicant, it was noticed by the Medical Board that the applicant was

having only one which eye was functioning properly. The other facts are disclosing that with one eye the applicant performing his duty was in the 26th department since year 2006 till September, 2013.

7. In view of this material, it is apparent that the certificate issued by the Medical Board with erasers in it, is wrong and it cannot be relied upon. Hence, this application is allowed and it is declared that certificate dated 12/01/2017 issued by the Medical Board is incorrect and it should not be acted upon. No order as to costs.
