The applicant has applied for the post of Assistant Store Keeper in pursuance to the advertisement dated (Annexure-A-4). From the admitted fact, it seems that one seat was kept open for Ex-Serviceman, O.B.C. Category and one for Scheduled Tribe Category. The applicant admittedly applied for O.B.C., Ex-Serviceman Category.

The Id. counsel for the applicant invited our attention to the result given in provisional merit list of the candidates at (Annexure-A-8) at P.B., Pg. No. 33. The said list however is not complete. It is stated that the applicant obtained 77.20 marks out of 200 marks and was at merit list no. 159. However, no steps have been taken to appoint him, and therefore, the applicant has prayed a direction to respondents to consider his case for appointment to the post.

The respondent no. 4 i.e. Joint Director of Vocational Education, Nagpur has filed affidavit-in-reply on 10/04/2017 and also the reply to the amended O.A. on 09/02/2018 and also return on behalf of respondent no. 4 has filed on 04/10/2018. In para no. 7 of the return it has been mentioned that, the applicant has secured 77.2 marks out of 200 marks, which was much less than the benchmark i.e. 45% as per the G.R. dated 27/06/2008 and, therefore, the applicant is not eligible for the post. It is further stated that one Shri Wanjari from the same category got qualified for the post of O.B.C. Ex-Serviceman. Since, he secured 99.6 marks and was called as per merit. However, Shri Wanjari did not appear to produce the documents and, therefore, nobody is appointed in the post which are reserved for O.B.C. (Ex-Serviceman).

The Id. P.O. also placed reliance on the G.R. dated 27/06/2008 (R-1), the copy of which is at P.B., Pg. No. 57-61 (both inclusive). The para no. 5 of the said G.R. reads as under:-

From the aforesaid contention, it will be clear that the required benchmark for qualification is 45% marks and applicant did not obtain in the written. The applicant however, did not qualify the such criteria and, therefore, could not be considered. Though Shri Wanjari found eligible, he did not produced the documents and, therefore, nobody was appointed. Merely because nobody is appointed for the post, the applicant cannot get any right to consider for appointment. It is discretion of Government and competent authority to issue fresh advertisement if the qualified candidates are not available.

We therefore, do not find any merit in the O.A. Hence, the order:-
