In the letter it was brought to notice of this office by Dr. Ajay Kasumbiwal that he has been allotted new G.P.F. number under N.P.S. Scheme. He has also stated that instead of crediting his G.P.F. deductions under his old G.P.F. number he has been treated as a new employee."

3. I fail to understand that when applicant was already having G.P.F. No. A/c No. MBN/21022 of Nagpur only. Then why there is a need of opening new G.P.F. Account.

4. The respondent no. 3 is directed to deposit the amount in old account number as per the directions of Accountant General after consulting the Accountant General, Nagpur and under A.G. guidance needful action to be done **within four weeks** from the date of this order.

5. With the above directions, **C.A. No. 189/2019 is disposed of.**
