2. The learned counsel for the applicant submits that despite of the interim order dated 2.9.2016, the applicant is reverted vide order issued on the very day i.e. on 2.9.2016 at 8.00 p.m. vide wireless message 9P.6). It is worthwhile to note that the order of interim relief was passed on the very day i.e. 2.9.2016 by this Tribunal. There is nothing on record that the



order was communicated to the Superintendent of Police, Buldhana so as to hold that the impugned order of reversion cannot be passed.

3. The learned counsel for the applicant submits that the applicant be allowed to work on promotional post. However, the learned P.O. submits that he has instructions that no order in respect of other similarly situated employees, continuing them on promotional post are issued. Interim relief granted by this Tribunal was a

conditioned one that the applicant be continued on the post till other similarly situated employees continued on an *ad hoc* basis as P.S.I. As per the statement of the learned P.O., nobody is continued.

4. Apart from that, the learned counsel for the applicant submits that this Tribunal at Mumbai Bench in O.A. Nos. 1215, 1227 and 1213 of 2013 decided on 4.7.2014 has continued the services of similarly situated employees. The learned P.O. submits that the case of the applicants therein and the present applicant does not stand on the same footing, because they were continued on the post because the channel of appointment and the percentage of direct recruits and promotees was involved in that case. The learned P.O. also submits that in that case, there was no question of appointment by the competent authority. However, in the case in hand, the appointment order is issued by the Superintendent of Police who is not the competent to issue such order.

Because the Dy. Inspector General of Police is the competent authority to pass promotional orders. This aspect is considered while passing the order of interim relief on 2.9.2016. However now, the learned P.O. relied on **Dhirendra Singh and others V/s State of Haryana and others (1997) 2 SCC-712**

wherein Their Lordships of the Summit Court of the land clearly held that if the ad hoc promotion made by an incompetent authority, the employee is not entitled for protection to be given for such promotion. The learned counsel for the applicant submits that the case was arising out of Punjab Police Manual and different rules arising therefrom. However, the principle holds the field.

5. Now, in such a situation, the applicant cannot get the benefit of the observations made in the O.As referred to above decided cases by this Tribunals, because their appointments were made by the competent authority whereas in the case in hand, applicant's appointment is not made by the competent authority. Therefore, even though the matter is travelling in the above situation, the order of interim relief cannot be extended. Thus the C.A. is disposed of.
