I fail to understand that why committee has considered C.Rs. of 2004-2005, 2005-2006 for it's "C" it has been considered "Lk/kj.k" and why C.Rs. of 2006-2007, 2007-2008 again for it's "C" it has been considered "plaxyk". In view of this, the original C.Rs. should be produced by Id. P.O.. during next hearing.

4. It is settled principle that if C.Rs. are against i.e. adverse of employee and if the same is not communicated to the employee then it cannot be used for its future promotion of the carrier. It must be communicated to the employee, if any representation is filed by him and it was disposed off according to law. Whether this procedure was adopted for these C.Rs. or not? There is also a Government Resolution of 1961, which provides that if any candidate belongs to the backward class then while considering his/her name in the promotion committee his case should be sympathetically considered.

5. The Id. P.O. is directed to file such G.R. either from Social Welfare Department or from Tribal Development Department. As per D.P.C. meeting dated 22/02/2010, the applicant

should be given the same date of promotion which Shri S.K.Kilnake and Shri S.S.Bhalavi were given. Respondents are directed to file the C.Rs. and relevant G.R. and also

reply to that effect that whether adverse C.R. was communicated to the applicant or not. Since applicant is retiring today his all pensionary benefits should be decided as per outcome of this O.A.. Respondents are further directed to file all these documents within stipulated time through Id. P.O.. So that decision can be taken during next hearing.

6. Steno copy is granted.
