The Tribunal granted interim relief on 1.7.2016, because the stay order was already operating in O.A. No. 324/2016. Now this O.A. is also decided. W.P. against it is also disposed of. However, the applicant is taking advantage of the interim order passed in this case on 1.7.2016. Ld. counsel for R.3 further urged that thus the applicant is taking disadvantage. Ld. Adv. for R.3 and Shri A.M. Ghogre, Ld. P.O. submit that this order dated 29.6.2016 is also withdrawn by the Government on 9.1.2017. However, Ld. counsel for

R.3 proceeded to argue that this is misuse of the process.

5. on the last date, the matter was adjourned at the instance of Ld. counsel for the applicant and fixed date was given. But it is not listed and Ld. counsel for the applicant is not present. Ld. counsel for R.3 insisted that the order should be passed because R.3 to retiring on 30.4.2017 and the applicant is misusing the process.

6. In presence of parties, an elaborate order can be passed to do justice between the parties.
