2. The applicant, an Associate Professor in Orthopedic has challenged the order dated 8.1.2016 (P.16) reverting him to the post of Assistant Professor in Orthopedic.

3. The applicant was promoted as Associate Professor in Orthopedic on an *ad hoc* basis vide order dated 27.6.2016 till 31.3.2017. The applicant is working from 2013, with technical breaks. Reversion is made on the ground that the applicant does not fulfill the criteria of requisite recruitment Rules i.e. of submitting two research papers. The applicant is appointed from 2013 and the recruitment rules came into force on 1.4.2015 (R.2). The term of the applicant is to come to an end on 31.3.2017.

4. As per Schedule 1 in the table clause No.17 of the Recruitment Rules, an Associate Professor in Orthopedic has to submit two research papers, accepted or published in index or national journal as a first or second author during the tenure of

Assistant Professor or Lecturer. It is submitted that the applicant has submitted the papers to the competent authority on 16.5.2016 and 12.7.2016. The learned C.P.O. submits that, however, he is not a first or second author and the same were not also submitted when the D.P.C. meeting was held on 29<sup>th</sup> July 2016. Thus, there are technical lapses in the matter. The learned C.P.O. further submits that, when the papers were submitted, the applicant was working as an Associate Professor, however, as per the requirement the papers are to be submitted during the tenure of Assistant Professor or Lecturer. Thus, this is a second technical lapse. In clause 17, these requirements are captioned under head "desirable".

5. If the applicant's case is considered in the light of the above facts, and when his tenure is upto 31<sup>st</sup> March, 2017 and he is not yet reverted and nobody is posted in his place, no prejudice would be caused to anybody. The papers are already submitted to the competent authority before DPC held. The cause is that they were not available before D.P.C. Moreover, the applicant is already given ad hoc promotion and his tenure is till 31.3.2017.

For these reasons, **status quo as on today be maintained till filing of reply or 31<sup>st</sup> March 2017 whichever is earlier.**

6 . Issue notice before admission to R. 2 returnable **after four weeks.**

7. Shri S.A. Deo, learned C.P.O. waives notice for respondent No.1. Hamdast granted.

8. Tribunal may take the case for final disposal at this stage and separate notice for final disposal need not be issued.

9. Applicant is authorized and directed to serve on Respondents intimation / notice of date of hearing duly authenticated by Registry, along with complete paper book of O.A

10. This intimation / notice is ordered under Rule 11 of the Maharashtra Administrative Tribunals (Procedure) Rules,1988, and the questions such as limitation and alternate remedy are kept open.

11. The service may be done by hand delivery, speed post or courier and acknowledgement be obtained and produced along with affidavit of compliance in the Registry within three weeks. Applicant is directed to file Affidavit of compliance and notice.
