2. The applicant, an Assistant Project Officer came to be promoted as Senior Research Officer vide order dated 3.10.2016 (P.19. A.1) and transferred from Chadrapur to Nandurbar.

3. The main contention of the applicant is that, the notification dated 24.4.2015 (P.27. A.3) is not followed. The learned CPO submits that there is one clarificatory notification issued on 16.7.2015, regulating transfers and postings of the officers promoted from Group-B to Group-A and that clarificatory notification is not placed on record. As such, the applicant cannot rely upon only earlier notification ignoring the clarificatory notification.

4. On this ground alone also, applicant's case cannot be considered.

5. The other ground raised is that, the applicant is an abandon / widow and such women are exempted from operation of Rule 4 and 6 of the Notification.

6. At this stage, the learned counsel for the applicant submits that he wants to file some documents on record, as per oral instructions to the CPO.
