3. The applicant is claiming appointment on compassionate ground in place of his deceased father. However, his claim was rejected vide communication dated 14.2.2014. The applicant has, therefore, prayed that the said communication be quashed and set aside and to direct the respondents to include his name in the list of

candidates to be appointed on compassionate ground.

It is respectfully submitted that, on the basis of application made by the applicant, the proposal for sanction was submitted to the Directorate of Accounts and Treasuries, Maharashtra Government, Mumbai and in response to the same by Govt. letter dated 15.11.2016 and by Director's letter dated 19.11.2016, it was suggested to give the benefit of appointment on compassionate ground to the applicant by initiating necessary action, as the Hon'ble Court has declared Shri Ajabrao Kewatkar as dead.

It is respectfully submitted that, in pursuance to the Govt. letter dated 15.11.2016 and the Director's letter dated 19.11.2016 has informed the Treasury Officer, Gadchiroli to initiate necessary action for appointment of the applicant on compassionate ground. It is further submitted that, in responses to that, the Treasury Officer, Gadchiroli vide letter dated 14.12.2016 informed the applicant to submit application alongwith necessary documents for his appointment on compassionate ground.+

5. From the aforesaid affidavit, it will be clear that the Govt. has now decided to declare applicant's father as dead and has also included the name of the applicant in the list of candidates to be appointed on compassionate ground. Not only that the applicant's name is being considered, it is being forwarded to the concerned officer at Gadchiroli. In view thereof, nothing survives in this O.A. and hence the O.A. is disposed of accordingly with no order as to costs.
