2. In the O.A. the applicant has challenged the impugned communication vide letter dated 28/08/2014 whereby his representation for promotion and grant of deemed date was rejected. The applicant has claimed promotion to the post of Head Clerk from December, 2009 as has been granted to the junior, i.e., respondent no.3, Shri R.P. Kohale.

3. During pendency of the Petition, the respondents have promoted the applicant to the post of Head Clerk vide order dated 10/11/2014. The same is marked Exh-X for the purposes of convenience. Immediately thereafter on 29/12/2015 the applicant has filed representation for deemed date of promotion which is marked Exh-X1. However no decision has yet been taken on his representation.

4. The learned counsel for the applicant submits that the application can be disposed of with direction to respondent no.2 to take decision on his representation dated 29/12/2015 and to convey the same to the applicant. In view thereof, the following order .

ORDER

The application stands disposed of with direction to respondent no.2 to take a decision on the representation filed by the applicant on 29/12/2015 as per rules and merits within a period of three months from the date of this order and any such decision taken, shall be communicated to the applicant in writing.
