2. The applicants are claiming that the Circular dated 25/10/2017 issued by respondent no.1 towards publication of provisional seniority cum gradation list of Tahsildars cadre for the period from 1/1/2004 to 31/12/2010 be declared as illegal, erroneous, arbitrary, discriminatory and bias.

3. The learned counsel for the applicants submits that even through the applicants have filed objections to the seniority list. The said objections are not yet decided and there is likelihood of seniority list being finalized.

4. The learned CPO submits that the process of deciding objections and finalizing seniority list is pending. He submits that he will take instructions as to what is the status of the objections taken by the applicants and within how many days said objections will be considered, for that purpose he seeks two weeks time. In view thereof, the matter be adjourned for two weeks for taking such instructions and in the meantime, issue notice to R-2 to 7, returnable in **two weeks**. Learned C.P.O. waives notice for R-1. Hamdast allowed.

5. Tribunal may take the case for final disposal at this stage and separate notice for final disposal shall not be issued.

6. Applicant is authorized and directed to serve on Respondents intimation / notice of date of hearing duly authenticated by Registry, along with

complete paper book of O.A. Respondent is put to notice that the case would be taken up for final disposal at the stage of admission hearing.

2. The applicant has challenged the impugned communication dated 26/12/2017 (Annex-A-7) whereby his appointment to the post of Police Constable, Grade-C from S.B.C. Sports Category has been cancelled. The reason for cancellation of such appointment is that the applicant did not produce the Sport Certificate as per the advertisement. The learned counsel for the applicant submits that the applicant has produced the certificate dated 13/3/2017 and the same was given for verification. The said certificate is admittedly prior to date of filing of application. It however seems that the said certificate has been cancelled by the respondent no.4 at the time of verification and the respondent no.4 has issued fresh certificate which is dated 26/4/2017 on the ground that the Vidarbha Power Lifting Association under which the applicant has participated in the sport event was recognized on 26/4/2017. The learned counsel for the applicant submits that no opportunity was given to the applicant while cancelling the earlier certificate. According to the learned counsel for

the applicant, no appointment order has yet been issued in the said category. In view thereof, the respondents are directed not to appoint anybody on the post of Police Constable from S.B.C. Sports Category in place of applicant till reply is filed.

3. Issue notice to R-2 to 4, returnable in **three weeks**. Learned C.P.O. waives notice for R-1. Hamdast allowed.

4. Tribunal may take the case for final disposal at this stage and separate notice for final disposal shall not be issued.

5. Applicant is authorized and directed to serve on Respondents intimation / notice of date of hearing duly authenticated by Registry, along with complete paper book of O.A. Respondent is put to notice that the case would be taken up for final disposal at the stage of admission hearing.

6. This intimation / notice is ordered under Rule 11 of the Maharashtra Administrative Tribunal (Procedure) Rules, 1988, and the questions such as limitation and alternate remedy are kept open.
