2. The applicant is Head of the Department (HOD) in the subject Applied Mechanics in Govt. Polytechnic, Nagpur. He has been transferred as Dy. Secretary at Mumbai vide impugned order dated 31.5.2017. The learned counsel for the applicant submits that the post which the applicant has been transferred is lower in grade than that of H.O.D. However, the learned CPO has pointed out to the G.R. dated 1.4.2015 which says that the pay of the employee who would give consent will be protected and that the period of such posting shall be at the most two years. The learned counsel for the applicant submits that the applicant has never given consent for such posting and whatever consent was given in the year 2015 and that too it was for administrative post at Nagpur, Pune or Amravati and not at Mumbai. This contention seems to be supported from the consent letter placed on record. The Ld. CPO has, therefore, requested for time to take instructions as to whether administrative post of

Dy. Secretary is available at Nagpur, Amravati or Pune for which consent was given and whether the applicant can be accommodated on these administrative post. Applicant has stated that he has not been relieved from his post. In view thereof, the respondents are directed not to relieve the applicant till further orders.
