2. The Id. P.O. has placed on record order in O.A. No. 352/2018 dated 09.07.2018 and order in Review Application No. 12/2018 in O.A. No. 352/2018 dated 15/10/2018. He also placed reliance on the Hon'ble High Court order in W.P. No. 4640/2018 order dated 30/07/2018. It appears that it was argued by Id. counsel for the applicant that there was recovery from subsistence allowance of the applicant during suspension period. The details are below:-

3. *However, Id. C.P.O. explained the matter in detailed and Id. C.P.O. submitted pay-slips of November 2015 to May 2018. In all these pay-slips, it is itself clear that recovery is not made from the subsistence allowance as submitted by the Id. counsel for the applicant. According to the impugned order no. i k v o l e y s t k e o r u 2 @ 9 0 5 6 @ 2 0 1 7] dated 21.12.2017, the applicant mentioned that recovery from the subsistence allowance is going on. However, it was pointed out by Id. C.P.O. that by order no. i k v o l e f o p l e i h & 6 7 1 / 2 0 1 7 i k g o k & 1 8 8 @ u - e q @ 2 0 1 7 v i n s k f r u n d 2 1 Dec. 2017, the applicant was reinstated and from the order no. i k v o l e y s t k e o r u 2 @ f o u l o r u & u l r e 5 7 2 5 @ 2 0 1 8 dated 16/07/2018, it is very much clear that further recovery is from the salary. As far as the question of his leave without pay between 09/12/2014 to 21/03/2015 is concerned, the Id. C.P.O. pointed out another O.A. No. 184/2016 of applicant is pending before this Tribunal only and that is yet to be decided."*

4. In view of this, order it appears that applicant is time and again trying to mislead the Tribunal which is totally unbecoming of Court Officer. Hence, **O.A. is dismissed at this stage with no order as to costs.**

3. The enquiry report has been submitted by order dated 11/01/1999 (Annexure-A-4, P.B., Pg. No. 25) on P.B., Pg. No. 44, it has been mentioned that both the two charges have been proved, final show cause notices was issued on 07/06/2013 (Annexure-A-7, P.B. Pg. No. 54) and final punishment order is dated 16.10.2015 (Annexure-A-1, P.B., Pg. No. 10). The applicant approached to this Tribunal vide this O.A.
