Opinion of the department was obtained on it on the very day, and thereafter, it had been placed before the Civil Services Board on the same day. Paper Book Page 44 shows that Civil Services Board made recommendations for transfer of the applicant in Gadchiroli region on 13-06-2017. Members and Chairman of the Committee approved and signed the recommendations. 2 members of the committee had signed it on 13-06-2017 while Chairman

i.e. Chief Engineer signed it on 12-06-2017. It creates confusion as to whether the meeting of the Civil Services Board was held on 13-06-2017 or 12-06-2017. Moreover, minutes of the meeting of the Civil Services Board are not placed on record. Not only this, but approval of the higher competent authority as provided u/s.4(4)(ii) and 4(5) of the Transfer Act to the transfer of the applicant on the recommendations of the Civil Services Board has been obtained or not is not clear from the record. Therefore, respondent no.1 is directed to file his affidavit on the following points:

- (i) To state as to whether the meeting of the Civil Services Board was held on 12-06-2017 or 13-06-2017.
- (ii) To state as to whether approval of the higher competent authority as provided u/s.4(4)(ii) and 4(5) of the Transfer Act has been obtained before transferring the applicant.

(iii) Respondents shall produce notification constituting Civil Services Board for transferring the employees.

3. Respondent no.1 is directed to file his personal affidavit on the above line on or before 28-11-2017.

4. Interim relief granted earlier to continue till then.
