7. As observed earlier, the Government Resolution dated 30<sup>th</sup> April, 2005 however, shows that for selection to 'C' and 'D' category services the recognition by Maharashtra Olympic Association is the only criteria.

8. The impugned communication is issued by the respondent No. 2 on the basis of the communication received to the said authority from the proposed respondent Nos. 4 & 5.
