On perusal of record, it reveals that by order dated 08-06-2017 respondents were directed to take corrective steps in view of the decision rendered by the Tribunal and by the Hon'ble High Court in case of similarly situated employees. In spite of directions given by the Tribunal respondents, more particularly, respondent nos.1 and 2 have not taken corrective steps, and therefore, this Tribunal has passed order dated 14-03-2018 and directed the respondents to take corrective steps by taking similar decision regarding grant of annual increments, earned leave ignoring technical breaks of the applicant in view of the decision passed by this Tribunal in other similar matters

and as per the direction of the Hon'ble High Court. Respondents are further directed that if they come to the conclusion that no corrective steps can be taken, a short affidavit be filed explaining reasons for the same. Therefore, the matter has been fixed for either taking corrective and if corrective steps cannot be taken then for filing a short affidavit explaining reasons for the same.

3. Today, the respondents neither filed any report showing that they have taken corrective steps nor they have filed a short affidavit explaining reasons for not taking corrective steps. This shows lethargy on the part of the respondent no.1 and 2 in taking appropriate decision in the matter. Respondents are flouting the orders of the Tribunal.

4. Hence, issue show cause notice to the respondent nos.1 and 2 as to why they should not be saddled with heavy costs, which shall be recovered from their personal pocket, for not

following the directions of the Tribunal and for showing lethargy on their part.
