3. Learned Advocate for the applicant has submitted that the applicant is serving at Nandurbar, which is semi tribal area since the year 2007. In the General Transfer of the year 2017, he made request to the respondents to give him posting of his choice in view of the G.R. dated 11.07.2000, but the respondents had not considered his options and posted him in Jalgaon District. He has submitted that in the present year, the applicant had given options for posting in his native district.

3. On perusal of the G.R. dated 11.07.2000, it reveals that the Government has directed the concerned to consider the cases of the employees of Group C and D, who were served in the tribal area for 3 years and for 2 years from Group A and B. It has been mentioned therein that the employees, who completed their tenure for the above said period in the tribal area, should be transferred to the District of their choice and for that purpose, they have to give options/names of three districts, where they will have to be transferred and posted, three months before completion of their tenure of posting. It seems that the applicant has to submit his willingness regarding districts, where he wants to be posted. The applicant has not submitted the options accordingly. Hence, the applicant is directed to give options of three districts, where he wants to be posted as per the G.R. to the respondents. On giving options by the applicant, the respondents have to consider the request of the applicant as per the G.R. dated 11.07.2000. The respondents are directed to take corrective

measures accordingly, as per G.Rs. dated 11.07.2000 and 06.08.2002 as per options given by the applicant. If they are not able to take corrective steps then, the concerned respondents shall file short affidavit explaining the reasons and legal impediment in that regard. The short affidavit be filed by the concerned respondents on or before the next date positively.
