Learned Advocate for the applicant has submitted that, the applicant has received the arrears of pay as per the order dated 14.3.2016 and the prayer clause 12 (A) mentioned in the O.A. has been satisfied. He has been submitted that, the applicant received all the arrears in the months of Aug, Sept. and Nov. 2017. He has submitted that, there is delay of more than one year to comply the order dated 14.3.2016 and therefore, he is entitled to claim interest.

3. Learned P.O. has submitted that, as per the directions given by respondent no.4 the bills regarding arrears of pay payable to the applicant has been prepared after complying the necessary requirements and thereafter the arrears has been

paid to the applicant. She has submitted that, the respondent no.4 made inquiry regarding the pay of the applicant when he was serving at Civil Surgeon, Ahmednagar and therefore, there was delay.

4. I have gone through the record. The affidavit in reply the respondents no.1 to 4 does not disclose that the delay in making payment occurred as the respondents had sought information from Civil Surgeon, Ahmednagar. On the contrary, inspite of repeated directions given by the respondent no.2, the respondent no.4 had not taken action to release the arrears of pay to the applicant as per the order dated 14.3.2016. No explanation has been given by respondent no.4 for delay caused for making payment of the arrears of pay to the applicant. Therefore, respondent no.4 Civil Surgeon, Nandurbar is directed to file his personal affidavit explaining the delay caused for making payment of arrears to the applicant and also show cause

as to why he should not be held responsible to pay the amount of interest claimed by the applicant.
