**“O R D E R**

- (1) Petition is partly allowed with no order as to costs.
- (2) The Enquiry Officer shall complete enquiry and submit the report to the Disciplinary Authority on or before 30.06.2011.
- (3) The Applicant shall co-operate the enquiry officer for completing the enquiry before 30.06.2011 and shall not seek adjournments.
- (4) Thereupon the Disciplinary Authority shall take decision on the enquiry report on or before 30.09.2011.

- (5) In the eventuality of Enquiry Officer not submitting enquiry report on or before 30.06.2011, or Disciplinary Authority not taking decision after submitting the enquiry report on or before 30.09.2011, amount of GIS, GPF and amount of encashment of unexhausted earned leave shall be paid to the applicant on or before 30.11.2011.”

3. The present M.A. filed by the applicant for condonation of delay in filing the accompanying O.A. would show that since no decision is communicated to him in this regard, he is in dark and, therefore, he is deprived of the pensionary benefits since long.
