2. Learned Advocate for respondent Nos. 2 to 4 has submitted that he will file affidavit in reply during the course of the day.

3. The applicant has filed the accompanying O.A. and prayed to issue directions the respondent No. 1 to decide the proposal dated 04.02.2016 sent by the respondent No. 2 to decide the application of the applicant to regularize his services. According to the applicant, there is a delay of 87 days in filing the accompanying O.A. and the said delay is not

deliberate and intentional and therefore, he prayed to allow the present M.A. and condone the said 87 days delay.

4. The respondents have resisted the contention of the applicant on the ground that delay has not been explained by the applicant properly and therefore, they prayed to reject the present M.A.

5. On perusal of the prayer clause made by the applicant in O.A., it reveals that the prayer clause B mentioned therein is well within limitation. The prayer made in the prayer clause-C is consequential relief, as the relief is based on decision of the respondent No. 1 on the proposal sent by the respondent No. 2 and therefore, the said cannot be considered for determining the limitation. Even if it is assumed that there is some delay, the said delay cannot be said to be deliberate and intentional as the representation of the applicant is pending with the respondent No. 2. The respondent No. 2 had sent the proposal to the respondent No. 1 long

back i.e. on 04.02.2016 and the same is pending with the respondent No. 1. Therefore, in my view, the applicant has explained the delay caused in filing the O.A. properly and satisfactorily. Therefore, in view of the said just reasons given by the applicant, the delay deserves to be condoned.

6. In view of the discussions in foregoing paragraphs, the M.A. stands allowed and the delay of 87 days caused in filing the accompanying O.A. is condoned. The O.A. be registered after due scrutiny.

"B. By appropriate order, direction, the respondent No. 1 be directed to decide the proposal bearing outward No. Ja.Pra.Ma./Astha-3/550 dated 04.02.2016 expeditiously and within stipulated time frame.

C. By appropriate order, the respondent no. 1 be directed to issue regularization order in favour of the applicant w.e.f. 20/01/1982 i.e. on completion of five years of service."

3. The main relief of the applicant is to issue directions to the respondent No. 1 to decide the proposal dated 04.02.2016 sent by the respondent No. 2. The respondent No. 1 has not taken decision on the said proposal till today. The respondents admit that the said proposal is still pending with the respondent No. 1.

4. In these circumstances, it is just and proper to direct the respondent No. 1 to take decision on the proposal dated 04.02.2016 sent by the respondent No. 2 within a period of three months from the date of this order and communicate decision therein to the applicant as per rules on merit.

5. In view of this, the O.A. stands disposed of with a direction to the respondent No. 1 to decide the proposal dated 04.02.2016 sent by the respondent No. 2 within a period of three months from the date of this order and communicate its decision to the applicant in writing as per rules on merit. There shall be no order as to costs.
