On perusal of the record, it reveals that this Tribunal has disposed of O.A. no. 701/2013 on 1.8.2017 and directed the respondents to call meeting of D.P.C. / Review D.P.C. and consider the case of the applicant for promotion to the post of Jailor, Grade-II in terms of Recruitment Rules, which are provided in prison manual. The respondents have filed M.A. no. 467/2017 along with Review Petition St. no. 1576/2017 for reviewing the said decision, but it was finally disposed of by the Tribunal on 6.12.2017. Thereafter meeting of the D.P.C. / Review D.P.C.

has been held on 8.12.2017 and conscious decision has been taken by the respondents.

4. The learned Advocate for the applicant submits that the decision taken by the D.P.C. on 8.12.2017 amounts to contempt of the order of the Tribunal. On perusal of the documents, it reveals that the respondents had conducted the meeting of the D.P.C. on 8.12.2017 after the decision in the review petition. Prima-facie, it appears that was no breach of the order of the Tribunal.
