2. The learned Advocate for the applicant has submitted that the applicant was appointed as a Medical Officer Class-III with the respondents w.e.f. 25.12.1970 and she has rendered her service continuously till 15.4.1983. It is her contention that thereafter she has been promoted on the post of Medical Officer Class-II. The applicant has made a request in writing to the Deputy Director of Health Services to revert her and the Deputy Director reverted her accordingly but no posting has been given to her thereafter. The applicant has filed a special Civil Suit bearing no. 202/1986 in the Court of Civil Judge Senior Division, Jalgaon for giving her posting and arrears of salary. The said suit was decreed on 2.7.1990 and the defendants therein were directed to give posting to the applicant as a Medical Officer and also to pay her the arrears of salary with interest. Against the said order the

Government has preferred appeal in the District Court, Jalgaon, but it has been transferred to this Tribunal and the same has been renumbered as a T.A. no. 171/1993. This Tribunal vide order dtd. 9.8.2002 has dismissed the said T.A. The learned Advocate for the applicant has further submitted that thereafter the applicant came to be retired in the year 2004 on superannuation but no posting has been given to her by the respondents till her retirement. Thereafter she made several representations to the respondents for grant of pension and pensionary benefits to her. He has submitted that on last occasion the applicant has filed representation dtd. 1.6.2015 to the respondents for granting pension and pensionary benefits to her but no decision has been taken by the respondents on the said representation till today.

3. The learned P.O. has submitted that no order has been passed by the competent authority reverting the applicant from Medical Officer Class-II to Medical Officer Class-III as requested by her. The applicant has not joined the duty since 15.4.1983 and she remained absent therefrom and therefore proposal for initiating a departmental enquiry against her has been sent to the Director of Health Services and it is still pending. He has submitted that after dismissal of the Appeal / T.A. by the Tribunal,

the applicant has not joined the duty and thereafter she attained the age of superannuation. He has submitted that the applicant has remained absent unauthorizedly and therefore she is not entitled for pension. The proposal submitted to the Director of Health Services in respect of initiation of departmental enquiry against the applicant for her unauthorized absence from duty is still pending.

4. On perusal of the record, it reveals that the applicant has not joined the duty since 15.4.1983. Her suit for posting came to be dismissed by this Tribunal in T.A. no. 171/1993. Thereafter she has not approached to the respondents to allow her to join her posting as Medical Officer Class. In the meanwhile, the applicant attained the age of superannuation in the year 2004. The applicant made several representations to the respondents for grant of pension and pensionary benefits considering her continuous service from the year 1970 to 15.4.1983. Her last representation is dated 1.6.2015 and the respondents have not taken any decision thereon. The fact that the applicant rendered continuous service for 13 years has not been disputed by the respondents.

5. In the circumstances, the respondents are directed to take a conscious judicious decision on

the representation of the applicant and to decide as to whether she is entitled for pension and pensionary benefits in view of her continuous service w.e.f. 25.10.1970 to 15.4.1983. The respondents are also directed to take a decision on the proposal sent for initiating a departmental enquiry against the applicant and as also about her retirement on superannuation. The respondents are directed to take decisions as directed above within a period of 2 months from today.
