Ltd (W.P no. 11574/2016), that the candidate belonging to reserved category has a right of consideration while considering the seats of all types which are not reserved and are open merit contest vacancies, and this right includes right to be considered even in horizontal reservation or special reservation.”

Today, the learned Advocate for the applicants has placed on record a copy of the communication dated 17.01.2018 sent by the Under Secretary, Maharashtra State to the Commissioner (Agriculture), Agriculture Commissionerate, Maharashtra State, Pune informing that two benefits under Assured Career Progression Scheme have been extended to the employees in view of the decision given by this Tribunal, Hon'ble High Court and Hon'ble Supreme Court.
