The applicant has filed the present Original Application praying to issue directions to the respondents to re-fix his pay; to grant him two advance increments as per the Government Resolution dated 15.10.1993; and to quash the proposal dated 29.04.2017 sent by respondent No. 2 to the Government.

3. Learned Advocate for the applicant has submitted that the applicant had filed earlier Original Application bearing No. 671/2011 before this Tribunal claiming same relief and it was disposed of on 6<sup>th</sup> May, 2016 with a direction to the applicant to file representation within a period of one month before the respondents and the respondents were directed to decide it within a period of three months with further direction to the respondents to give an opportunity to the applicant of personal hearing. He has submitted

that in spite of the directions given by this Tribunal, the respondents have not decided the representation made by the applicant on 9.6.2016. He has submitted that on 29.4.2017 the respondent No. 2 i.e. the Director, Medical Education and Research, Government Dental College & Hospital Building, Mumbai, forwarded his report/proposal in the matter to the Principal Secretary regarding the representation of the applicant, but the respondent No. 1 has not taken any decision on it till today and, therefore, the applicant has approached this Tribunal by filing the present Original Application.

4. On going through the record, it reveals that the applicant had filed earlier Original Application bearing No. 671/2011 claiming the similar relief and the said Original Application has been disposed of by this Tribunal on 6<sup>th</sup> May, 2016 with a direction to the respondents to decide the representation filed by the applicant within a period of three months. On the said representation the respondents have given hearing to the applicant and thereafter the respondent No. 2 sent a proposal dated 29.4.2017 to the Secretary, Medical Education and Drugs Department for taking appropriate decision thereon. The applicant has challenged the said proposal.

2. The applicant has filed the present Original Application seeking direction to the respondent No. 2 to complete the recruitment process for the post of Police Patil of village Kachner, Tal. & Dist. Aurangabad and to appoint her on the said post. It is contention of the applicant that she is belonging to Dhangar Caste, which comes in NT (B) category. It is her contention that respondent No. 2 issued a publication to fill in various posts of Police Patil in Aurangabad Division including the village Kachner Tal. & Dist. Aurangabad. The post of the Police Patil of village Kachner has been reserved for Other Backward Category (Women) category. It is her contention that she has applied for the post of Police Patil of village Kachner. Accordingly, she has appeared for the written and oral examination. According to her, she was the only candidate, who was held to be eligible for appearing the examination, which was to be held on 28.02.2016. After examination,

respondent No. 2 declared the applicant as successful candidate and published a provisional select list on 5.3.2016. But thereafter respondents had not issued appointment order in her favour. The applicant was orally informed that she was not eligible for appointment on the post of Police Patil as she was not belonging to OBC category, but no written order has been passed by the respondents in that regard. Therefore, the applicant is seeking direction to respondent No. 2 to complete the recruitment process and to issue appointment order on the post of Police Patil in her favour.

3. The respondents have resisted the present application. It is their contentions that the applicant has appeared for written and oral examination and she was declared as successful candidate and her name has been included in the provisional select list. At the time of verification of original documents it was disclosed that the applicant was belonging to Dhangar Caste, which comes in NT (B) category. It is their contention that the post of Police Patil of village Kachner, Tal. & Dist. Aurangabad, has been reserved for the candidates belonging to OBC (Women) category. The applicant was not belonging to OBC category and, therefore, she is not eligible for the appointment on the post of Police Patil, Kachner, Tal. & Dist. Aurangabad. As the

applicant was not eligible, she has not been appointed on the post of Police Patil. On this ground they prayed to reject the present Original Application.

4. Learned Advocate for the applicant has submitted that the candidature of the applicant has not been objected by the respondents till she appeared for written and oral examination. She was the only candidate, who was held to be eligible for appearing the written and oral examination for the post of Police Patil for the village Kachner. She has secured 41 marks in written examination and 15 marks in oral examination. She has secured total 56 marks and accordingly on 5.3.2016 the respondent No. 2 published a provisional select list. Thereafter, the applicant was called for verification of the original documents and on verification of the original documents the respondents came to know that the applicant was belonging to Dhangar Caste, which comes in NT (B) category. According to the applicant, till verification of the documents, the respondents never objected that she was not eligible for appointment on the post of Police Patil and no appointment order has been given to her. He has submitted that the respondent No. 2 ought to have completed the recruitment process by taking appropriate decision in the matter and, therefore, he prayed

to allow the present Original Application and to issue directions to the respondents in that regard.

5. Learned Chief Presenting Officer has submitted that the applicant has suppressed the material fact that she was not belonging to OBC category. He has submitted that the post of Police Patil of village Kachner was reserved for the candidate belonging to OBC (Women) category. He has submitted that the applicant appeared for written and oral examination by suppressing the fact that she was not belonging to OBC category. She was the only candidate appearing for written and oral examination. She has secured 56 marks in aggregate. Thereafter, she was called for verification of the original documents and at that time it was disclosed that the applicant was belonging to Dhangar Caste, which is NT (B) category and she is not belonging to OBC and, therefore, the appointment was not given to her as she was not eligible. Therefore, he prayed to reject the present Original Application.

6. On considering the documents on record, it reveals that the applicant was the only the candidate declared as eligible for appearing for the written and oral examination for the post of Police Patil of village Kachner, Tal. & Dist. Aurangabad. Therefore, her examination was conducted and result was declared. Admittedly,

the post of Police Patil of village Kachner was reserved for candidates belonging to OBC (Women). Admittedly, the applicant is belonging to Dhangar Caste, which comes in NT (B) category. The applicant was allowed to appear for written and oral examination on the basis of the application filed by her. As she was single candidate appeared for the examinations, her result was declared and provisional select list has been published by the respondents on 5.3.2016. Thereafter, she was called for verification of original documents and at that time it was disclosed that she was not eligible candidate as she was not belonging to OBC category and, therefore, the respondent No. 2 orally informed the applicant accordingly, but no written order has been passed by the respondent No. 2 declaring the applicant as ineligible for the post of Police Patil, as the applicant was not belonging to OBC category. In fact, the respondent No. 2 ought to have passed the necessary order in that regard and completed the recruitment process, but he has not passed the written order and not completed the recruitment process. Therefore, it is necessary to direct the respondent No. 2 to complete the recruitment process by taking appropriate decision as regards eligibility of the applicant for the appointment of Police Patil of village Kachner, Tal. & Dist. Aurangabad.

7. In view of the above, the present Original Application is allowed.
