1. Heard Shri M.C. Syed, learned Advocate for the applicants and Shri M.P. Gude, learned Presenting Officer for the respondents, present.

2. Learned Advocate for the applicant points towards sub-paragraph No. (T) of paragraph No. 4 of the O.A. to buttress his submissions that priority quota amongst the horizontal reservation for the persons, who are affected by the particular project will have to be maintained by the particular department. He relies on the provisions of Section 6 (c) of the Maharashtra Project Affected Rehabilitation Act, 1999 to that effect.

3. In reply the respondent Nos. 1 to 3 vide para No. 23 of their affidavit in reply have averred as under: -

“23. As regards to contents in para No. 4 (T) it is submitted that, reliance of applicants on proviso to section 6 (c) of the Act of 1999 is not tenable in view of reply given to paras here in above same are denied being devoid of merit.

4. In paragraph 22 they further submits that in view of the full bench decision of the Hon'ble High Court in the case of **RAJENDRA PANDURANG PAGARE AND ANOTHER VS. STATE OF MAHARASHTRA AND OTHERS** reported in **2009 (4) Mh.L.J. 961** and in view of the subsequent G.R. dated 27.10.2009 the reliance on the said provision is untenable in the eye of law.

5. In view of the above fact, decision at the hands of the Division Bench would be required. In the circumstances, S.O. to 14.01.2019 for hearing on the above line.
