The applicants who were serving as a Muster Clerk/Technical Assistant with the respondents have filed the present O.As. with a prayer to direct the respondents to grant time bound promotional pay scale in view of the judgment delivered by this Tribunal in O.A. No. 344/2014 on 05.12.2017 and the decision rendered by the

Hon'ble High Court of Judicature Bombay, Bench at Nagpur in W.P. No. 5185/14 with W.P. No. 5732/14 with 5838/14 on 08.06.2015.

3. Learned Advocate for the applicants has submitted that the issue involved in all these O.As. has already been decided by the Division Bench of this Tribunal in O.A. No. 344/2014 on 05.12.2014, as well as, in W.P. No. 5185/14 with W.P. No. 5732/14 with 5838/14 by the Hon'ble High Court of Judicature Bombay, Bench at Nagpur on 08.06.2015 and the decision rendered by the Hon'ble High Court of Bombay, Bench at Aurangabad in W.P. No. 9279/2016 on 30.11.2017. He has further submitted that recently the said issue has been again decided by this Tribunal in O.A. No. 395/2015 on 27.03.2018. Copy of the same is placed on record.

4. He has submitted that the posts of Technical Assistant/Muster Clerk have been amalgamated and upgraded to the post of Civil Engineering Assistant in view of the G.R. dated 31.01.1989 and therefore, the employees, who were working on the said post i.e. Technical Assistant /Muster Clerk and who have completed 45 years of their age are exempted from appearing for the examination required for the post of Civil Engineering Assistant. Therefore, the applicants will have to be treated as Civil

Engineering Assistant on completion of their age of 45 years and granted next time bound promotion, but the respondents have not considered their cases and therefore, they have filed the representation with the respondents.

5. He has submitted that in the earlier O.A. decided by this Tribunal, as well as, in the W.P. decided by the Hon'ble High Court, the directions were given to the respondents to consider the cases of those applicants in view of Rule 3 Sub Rule (a) of the 1998 Recruitment Rules for Junior Engineers regarding exemption from passing of the professional examination on reaching 45 years of age, provided that the applicants meet all other criteria as per schemes of time bound promotion. Therefore, he has submitted that in the light of the decisions rendered by this Tribunal and the Hon'ble High Court, the present O.As. be disposed of with similar direction.

6. Learned Presenting Officer as well as learned Advocates for respondents have submitted that they have no objection to issue direction to the respondents to decide the representation of the applicant within reasonable time in the light of the decision rendered by this Tribunal in O.A. No. 344/2014 on 05.12.2017, judgment of Hon'ble High Court of Judicature at Bombay, Bench At Aurangabad in W.P. No. 9279/2016 decided on 30.11.2017 and in the

light of the judgment of Hon'ble High Court of Judicature, Bench at Nagpur in W.P. No. 5185/14 with W.P. No. 5732/14 with 5838/14 on 08.06.2015.

7. Considering the above said facts and the submissions advanced by both the parties, in my opinion, it is just and proper to dispose of the present O.As. in the light of the directions given by this Tribunal in O.A. No. 395/2015 and O.A. No. 344/2014. Therefore, I pass the following order:-

**ORDER**

- (i) The Original Application Nos. 709/15, 710/15, 711/2015, 364/16, 768/16, 895/16, 904/16, 908/16 and 155/17 are disposed of without any order as to costs.
- (ii) The respondents are directed to consider all the applicants for grant of time bound promotion as well as assured career progression scheme by exempting them from passing of the professional examination as required under Rule 3 Sub Rule (a) of the 1998 Recruitment Rules for Junior Engineers on reaching 45 years' age, provided that the applicants meet all other criteria as per schemes of time bound promotion.
