He has not completed his tenure of posting of three years on the said post but by the order dated 23.07.2018 he has been abruptly transferred from Dhule to Jalgaon. He has further submitted that the respondent No. 4 has been promoted as an Executive Engineer by an order dated 6.4.2018 but no posting was given to him. He has been posted in place of the applicant by the impugned transfer order dated 23rd July, 2018. He has submitted that the transfer of the applicant has been made to accommodate the respondent No. 4, who is serving at Dhule only. He has submitted that the applicant has not been yet relieved, but the respondent No. 4 is in hurry to take charge of his

post. He has submitted that the transfer of the applicant is in contravention of the provisions of the Maharashtra Government Servants Regulation of Transfers and Prevention of Delay In Discharge of Official Duties Act, 2005 (In short "the Transfer Act of 2005) and, therefore, he prayed to grant interim relief as prayed for.

3. Learned Chief Presenting Officer has submitted that the instructions have been received to him that the respondent No. 4 has been relieved by the Superintending Engineer, Quality Control Division, Aurangabad on today before office hours to join his new post. On instructions from Mr. Navsare, Office Superintendent in the office of respondent No. 3, he further states that the applicant has not been yet relieved by this time. He has submitted that the impugned order has been issued by following the provisions of the Transfer Act of 2005. Therefore, he prayed to reject the interim relief.

4. Learned Advocate for the respondent No. 4 has submitted that the respondent No. 4 has been relieved by the Superintending Engineer, Quality Control Division, Aurangabad, today in the morning and thereafter he has joined his new post in the afternoon. He has produced the copy of the communication in between respondent No. 4 and respondent No. 3.

5. On perusal of the record, it reveals that the transfer of the applicant has been made in the midst of the term. Prima-facie it reveals that the impugned order is issued in contravention of the provisions of

the Transfer Act of 2005. It has been specifically mentioned in the order that the superior officers of the applicant and respondent have to pass the necessary orders relieving them and joining their new posting and inform the Government accordingly by E.mail. As submitted by the learned Chief Presenting Officer the applicant has not been yet relieved from his present posting. Even then the respondent No. 4 on his own accord joined the posting though relieving order to relieve the applicant has not yet been issued by the respondent No. 3.

6. In these circumstances, it is just to protect the applicant. Therefore, respondent No. 3 is directed not to relieve the applicant till filing of the affidavit in reply by the respondents.

7. Issue notices to the respondents, returnable on 7th August, 2018

8. Tribunal may take the case for final disposal at this stage and separate notice for final disposal shall not be issued.

9. Applicant is authorized and directed to serve on Respondents intimation/notice of date of hearing duly authenticated by Registry, along with complete paper book of O.A. Respondents are put to notice that the case would be taken up for final disposal at the stage of admission hearing.
