On the face of the record, it reveals that the mask transfers i.e. general transfers have been made by the impugned order on 17<sup>th</sup> July, 2017 and the applicant has been transferred to Solapur from Osmanabad, though he had not given option for Solapur. The record shows that the proposals for general transfers have been prepared by the Government in the month of May, 2017, but it has been approved by the Hon'ble Chief Minister on 15<sup>th</sup> July, 2017. The Civil Services Board (for short "the Board") had recommended the transfer of the applicant at Jalna, but said recommendation has not been accepted by the Hon'ble Education Minister and he made certain changes in the recommendation, but no reasons have been recorded for making changes in the recommendation of the Board. The respondents have come with the case that the transfer of the applicant has been made under Section 4 (4) (ii) of the Maharashtra

Government Servants Regulation of Transfers And Prevention of Delay In Discharge of Official Duties Act, 2005, but no administrative or special reasons or special circumstances have been mentioned while making transfer of the applicant. It seems that it is a midterm transfer.

3. In the circumstances, it is just to direct the respondents to reconsider the decision of transfer of the applicant at Solapur. If they reconsider it then take corrective measures accordingly.
