(Pension) Rules, 1982 to which she would become entitled in view of grant of Prayer Clauses ‘A’ and ‘B’ in her favour.”

3. Affidavit in reply of the respondent State would show that since the voluntary retirement notice was sent through proper channel, it was received by the

respondent State after the period of notice was expired and, therefore, there cannot be deemed acceptance of voluntary retirement notice. Second contention of the respondent State is that, since the present applicant has not completed 20 years qualifying service, no voluntary retirement notice can be accepted.

4. Admitted fact is that the present applicant was appointed as a Medical Officer on ad-hoc basis on 23.8.1992 . It is thus clear that the respondents are discounting the period of ad-hoc service for computing the period of qualifying service of the applicant.

5. This Tribunal in catena of judgments including O.A. no. 535/2017 dtd. 2.4.2018 and O.A. no. 941/2017 dtd. 11.4.2018 has taken a view that when Government itself on the basis of Circulars quoted in those judgments is granting the benefit of continuity of ad-hoc service for grant of retiral benefits, how the notice of voluntary retirement of the present applicant can be rejected on that ground.

6. In the circumstances, in the interest of justice, the present O.A. deserves to be allowed and is allowed as follows :-

(i) Impugned communication dtd. 22.3.2018 (Annex. A. 8 page 29) is hereby quashed and set aside.

- (ii) This Tribunal directs that applicant's request for voluntary retirement submitted by her through the notice dated 8.5.2017 (Annex. A. 4
