He has filed on record a copy of communication dated 23rd February, 2018 received to her and submits that four months' time may be granted for finalizing of the recruitment rules. The copy of the said communication is taken on record and marked as document 'X' for the purposes of identification.

3. In view of the aforesaid request made by learned Presenting Officer, S.O. to 24th July, 2018. Interim relief granted earlier to continue till further orders.
