2. Learned Advocate for the applicant submits that the applicants were appointed on contract basis for the period of 11 months in 2016 on the post of Scientific Assistant. They have been continued on the post thereafter from time to time. He has submitted that Principal Seat of the Tribunal at Mumbai has considered the cases of the similarly situated persons and granted interim relief directing the respondents to continue services of those applicants on the same terms and conditions as before and also directed not to discontinue their services. He has produced copy of the order passed by the Hon'ble Chairman, M.A.T. Mumbai in a group of cases i.e. O.A.No.734/2018 & Ors. He has submitted

that case of the present applicants is also similar to that of the cases of the applicants in these O.As. Therefore, he has prayed to pass interim order in favour of the applicants accordingly.

3. Learned P.O. has submitted that the applicants are appointed on contract basis for a particular period. He has submitted that recruitment process for appointment on the post of Scientific Assistant is in progress and the department is going to appoint eligible candidates on the said posts. He has further submitted that applicants are appointed on contract basis and their contract will come to an end on 05-10-2018. Therefore, the learned P.O. has prayed to reject the prayer of the applicants for grant of interim relief.

4. On going through the record it reveals that the concerned department has issued advertisement inviting applications from eligible candidates for appointment on the post of Scientific Assistant as per the recruitment rules.

Applicants have also participated in the selection process. Written test is conducted. Further recruitment process is in progress. Final select list has not yet been published. The applicants have been appointed on the recommendation of the selection board. They are serving since the year 2016. Their contract will come to an end on 05-10-2018. In the identical situation, Hon'ble Chairman has granted interim relief to the similarly situated employees in O.A.No.734 & Ors. pending before the Principal Seat of this Tribunal at Mumbai. Paragraph 15 of the said order reads as under:

“15. This Tribunal therefore, by way of ad-interim order directs that the applicants' services shall be continued on the same terms and conditions as before and none amongst them shall be discontinued. In case any amongst the contract employees is/are discontinued, he/they be engaged on contract basis as before and this Tribunal directs accordingly, by way of ad-interim order.”

5. In view of the abovesaid order passed by the Principal Seat of the Tribunal in a group of cases i.e. O.A.No.734/2018 & Ors., it is just and proper to grant interim relief to the present applicants also.

6. Accordingly, respondents are directed to not to discontinue the services of the applicants and services of the applicants shall be continued on the same terms and conditions as before till filing of the reply by the respondents.

7. Learned P.O. seeks time to file affidavit in reply on behalf of the respondents. Time is granted.
