6. The service may be done by Hand delivery, speed post, courier and acknowledgement be obtained and produced along with affidavit of compliance in the Registry within one week. Applicants are directed to file Affidavit of compliance and notice.

7. In case notice is not collected within 7 days or service report on affidavit is not filed 3 days before returnable date, O.A. shall stand dismissed without reference to Tribunal and papers be consigned to the record.

8. Learned Advocate for the applicant submits that interim relief in terms of prayer clauses 'B' & 'C' may be granted.

9. By the present Original Application the applicant is challenging the act of the respondent No. 2, Maharashtra Public Service Commission, in conducting the main examination for recruitment in Maharashtra Agricultural Services, Group 'A' & 'B' only in English medium without giving alternative in Marathi medium. The said exercise however was carried for preliminary examination.

10. It is to be noted that the recruitment notice along with the impugned decision was notified by the respondent No. 2, M.P.S.C. on 7th March, 2018 (Exhibit 'F', pages-33 to 36)

and now the main examinations are to be held on 8th September, 2018 i.e. just within 3 days from today.

11. The applicant has not approached the proper forum despite the notification dated 24th July, 2018 [Exhibit 'I' page-71] till this date. Now granting stay to the main examination would put a spoke in the entire arrangement made by the respondent No. 2 in conducting the examination by making all the arrangement and which would cause huge loss in terms of finances and also to the other numerous candidates who had not challenged the said provision and are ready to undergo the said examination.

12. In that view of the matter, prayer for interim relief cannot be granted to that effect. Therefore, the prayer for grant of interim relief is rejected.

6. Admittedly, the present applicant holds bachelor degree in Business Administration. The recruitment rules (Annex. R. 3 page 116) and more particularly rule 6 thereof along with advertisement (page 29) would show that the candidate should possess following qualification :-

“6. Appointment to the post of Assistant Director in the Maharashtra Finance and Accounts Service, shall be made either :-

(a) -- -- --

(b) by nomination from amongst the candidates who –

(i) -- -- --

(ii) possess any of the following qualifications :-

(a) a degree with at least fifty percent marks in Commerce, or

(b) passed final examination of chartered accountant conducted by Institute of Chartered Accountants of India,

(c) have passed the final examination of cost accountancy conducted by the institute of cost and Works Accountants of India, or

(d) Masters degree in Commerce of, or

(e) Master of Business Administration (M.B.A.) in Finance approved by All India Council For Technical Education (A.I.C.T.E.).”

7. The reason given by the res. no. 2 on the basis of communication received to it from the Finance Department, which is eventually based on the communication of the Director of Higher & Technical Education is that, though the degree of B.B.A. falls under the branch of Commerce and Administration, the nature of work of the post is of Accounting and, therefore, degree of B.B.A. is not included in the qualifications as detailed supra.

8. Learned Advocate for the applicant vehemently submits that, admittedly the degree B.B.A. falls under Commerce branch and, therefore, the present applicant was very well qualified for the post in view of qualification 6 (b) (ii) (a) mentioned supra.

9. Learned P.O. as well as learned Advocate for res. no. 3, however, submit that Commerce faculty falls under U.G.C., while Business Administration is under control and supervision of A.I.C.T.E.

10. Shri Deshpande, learned Advocate for res. no. 3 further submits that qualification 6 (b) (ii) (e) as mentioned supra would show that even degree in Business Administration is accepted for the post in question, provided it is Masters degree in Finance.

11. Upon hearing both the sides, it appears that, though qualification 6 (b) (ii) (a) is of general character i.e. degree in Commerce, the list of next of the qualifications as well as nature of the post would show that Finance & Accounting are the only job requirement of the said post. Therefore, the present O.A. cannot be allowed.
