Applicant is claiming deemed date of promotion on the ground that he had passed professional examination which was necessary for promotion on the post of Junior Engineer in the year 1990 in view of the G.Rs. dated 16-09-1964 and 07-06-1965. His seniority ought to have been mentioned in the category of Junior Engineers w.e.f. 01-02-1991, and accordingly, he ought to have been considered eligible for the promotion but the respondents had given him promotion w.e.f. 23-02-2012 (paper book

page 14). Therefore, he approached the Tribunal with the request to grant deemed date of promotion from the date of passing professional examination i.e. from 01-02-1991.

3. Learned Advocate for the applicant further submitted that the applicant had made representation dated 27-09-2012 to the respondents which was forwarded to Superintending Engineer, Jalgaon. The applicant has filed another representation dated 28-05-2015 addressed to the Secretary but the said representation has not been decided by the respondents though forwarded by the proper authority. He has submitted that similar issue was involved in O.A.No.233/12, 234/12, 235/12 and 236/12 before the Principal Seat of the Tribunal at Mumbai and it was decided on 07-10-2013, wherein relief had been granted to the applicants in those matters. He has submitted that as the similar issue had already been decided, it is necessary to give the benefits on the same line as claimed by the applicant to him.

4. Learned P.O. has submitted that the applicant is not entitled to get deemed date of promotion as claimed by him as the G.R. dated 16-09-1965 has been wrongly interpreted by the applicant. She has submitted that respondents have not yet decided the representations of the applicant.

5. In view of the abovesaid facts, it is crystal clear that the representations made by the applicant are still pending with the respondents and they have not yet decided the same. Principal Seat of the Tribunal at Mumbai had decided similar issue involved in other O.As. In these circumstances it would be just and proper to direct the respondents to decide the representations filed by the applicant, which are pending with them since the year 2012 within 2 months from the date of this order by considering the decision rendered by this Tribunal in aforesaid O.A.No.233/12, 234/12, 235/12 and 236/12. Therefore, respondent no.1 is directed to take decision on the
