2. It is contention of the applicant that vided order dated 13/06/2018 the applicant was transferred from Ramtek, District Nagpur on the ground that there were complaints against the applicant, but posting was not given to the applicant. The applicant challenged that transfer order in O.A.424/18. In that proceeding order was passed on 18/6/2018 and it was directed to maintain status-quo till next date of hearing. It is submitted that lateron the applicant was placed under suspension vide order dated 30/8/2018 and during period of suspension his head quarter was Civil Hospital, Chandrapur. The applicant is challenging the impugned order dated 19/9/2019. By this order, the respondent no.1 revoked the suspension of the applicant and posted him at Rural Hospital, Audha Nagnath, District Hingoli as Medical Superintendent. It is submission of the applicant that during period of suspension, he was not paid subsistence allowance or any monetary benefits to which he was entitled as per the service rules and disregarding the order of status-quo the present order is passed. In these circumstances, it is contention of the applicant that the order of transfer dated 19/9/2019 be stayed and during pendency of this application, the respondents be directed to allow the applicant to resume duty as before his suspension at Ramtek.

3. After hearing the submissions of the applicant and perusing the documents, it seems that in pursuance of the complaint there was inquiry, the matter was enquired by the Committee. The Members of the Committee were divided and some Members formed a view that it was not a complaint pertaining to the harassment of the lady at the work place, but some Members arrived to the contrary conclusion. It appears that the applicant is seeking mandatory injunction order ex-parte and such relief can be granted only in rarest of the rarest cases. As the applicant was under suspension and his headquarter was at Chandrapur, it was necessary for the applicant to report at his head quarter during the period of suspension, because, that Authority was competent to draw the suspension allowance. It is not clear whether the applicant reported to the Civil Surgeon, Civil Hospital, Chandrapur during the period of the suspension. It is

contention of the respondents that as per the policy decision taken by the Government that the Government servant who is placed under suspension and who is facing the departmental inquiry, should not be posted in the same area where alleged misconduct was committed by him.

4. Under these circumstances, it is not suitable to grant ex-party relief in this matter and therefore I direct to issue notice to R-2 to 6, returnable **after two weeks**. Learned P.O. waives notice for R-1. Hamdast allowed.

5. Tribunal may take the case for final disposal at this stage and separate notice for final disposal shall not be issued.

6. Applicant is authorized and directed to serve on Respondents intimation / notice of date of hearing duly authenticated by Registry, along with complete paper book of O.A. Respondent is put to notice that the case would be taken up for final disposal at the stage of admission hearing.

2. It is grievance of the applicant that vide order dated 20/2/2019 she was transferred as Sub Divisional Officer, Ralegaon, District Yavatmal. Thereafter, she completed the Training and after completion of her Training, the applicant resumed her duty at Ralegaon. The applicant received order dated 20/9/2019 by

which the applicant came to be transferred from Ralegaon to Yavatmal on the post of Dy. Collector, Bembala Project. It is submitted that the transfer order is premature and the Divisional Commissioner, Amravati who issued the transfer order, had no authority in law to transfer the applicant.

3. It is also contended by the applicant that vide order dated 20/9/2019 Shri Shailesh Kale, the respondent no.4 was posted as Sub Divisional Officer, Ralegaon, District Yavatmal and thereafter second order was passed on 21/9/2019 by which the respondent no.5, the Dy. Collector (Land Acquisition), Washim was transferred to Ralegaon, District Yavatmal as Sub Divisional Officer and the respondent no.4 was transferred to Yavatmal as Dy. Collector (Revenue). It is submitted that this is malafide exercise of jurisdiction and the impugned order are in contravention of law, therefore, the impugned order be stayed. It is submitted that the applicant is yet no relieved from the post and therefore there is no hurdle in granting interim relief to the applicant.

4. I have perused the impugned order dated 20/9/2019. In para-2, it is specifically mentioned that unilateral decision was taken by the Divisional Commissioner, Amravati and he relieved the applicant from the duty. Secondly, in para-3 of the order, it was directed that the applicant should hand over her detailed charge of the post to other officer and shall join the new posting within 24 hours. In para-4 it is again

cleared that the said transfer was in pursuance of the Election Programme for the elections of Legislative Assembly,2019 and on failure to obey the order, would be the offence under the People's Representative Act,1950 and would take action as per the Maharashtra Civil Services (Disciplinary & Appeal) Rules,1979. After reading clause-2 of the order, it is clear that the applicant is already relieved from the duty. The law is time to time explained by the Hon'ble Apex Court that the Government

servant who is transferred shall obey the transfer order promptly and he may challenge the legality of the order in the Court or Tribunal. Though it is contended that the respondent no.2 has no authority in law to transfer the applicant, but it appears that the reference in the transfer order is given that as per the direction received from the Government of Maharashtra, Revenue and Forest Department dated 9/9/2019 and direction received from the Election Commission, the order was issued. In view of this, in my opinion it is not suitable to grant any interim protection at this stage. The applicant may resume the duty without prejudice her right to challenge the legality of the transfer orders.

10. In case notice is not collected within **three days** and if service report on affidavit is not filed **three days** before returnable date. Original Application shall stand dismissed without reference to Tribunal and papers be consigned to record.
