(c) Are qualified Nurses and Midwives who are registered with the Maharashtra a Nursing Council or are eligible for such registration

(d) Possess experience in Nursing Administration or teaching for not less than five years after qualifying.

Provided that candidate possessing B.Sc. degree in Nursing or any equivalent degree recognized by the Indian Nursing Council shall be eligible if they possesses experience in administration or teaching not less than five years after graduation.

Provided further that preference will be given to candidates possessing post Graduate

*qualification in Nursing
Administration or teaching."*
