NOTIFICATION

(A) It is notified that Annual vacations, holidays for the year 2017 and working arrangement for Special holidays for Maharashtra Administrative Tribunal, Mumbai and its Benches at Aurangabad and Nagpur shall be as follows :-

- 1) Summer Vacation shall be from 08.05.2017 to 04.06.2017. (Both days inclusive).
- 2) Diwali Vacation shall be from 17.10.2017 to 29.10.2017. (Both days inclusive).
