He has submitted that the respondent No. 5 will take a charge of the post of the applicant and there is likelihood that the Deputy Director of Health Services, Latur, may issue order in that regard and therefore, he has filed the present Original Application.

3. On perusal of the record, it reveals that the applicant has not been aggrieved by any order. The respondent No. 5 was appointed on the vacant post of Medical Officer, P.H.C. Bhada, Tq. Ausa, Dist. Latur by order dated 15.12.2017. In these circumstances, in my opinion, there is no cause of action to the applicant to file the present O.A. Therefore, the O.A. is not maintainable.
