2. The facts of the case are that vide order dated 31st May, 2019, the applicant was transferred from BGW Hospital, Gondia to Sub District Rural Hospital, Tiroda, Dist. Gondia. The applicant was on maternity leave and she was permitted to join duty in Sub District Rural Hospital, Tiroda after availing maternity leave. In the meantime, on 19-07-2019, second transfer memo was issued and the respondent no.4 who was earlier transferred vide order dated 31-05-2019 to Gadchiroli was transferred to Sub District Hospital, Tiroda. It seems that when the applicant went to resume duty at Tiroda, Medical Superintendent has not allowed the applicant to resume the duty on the ground that the post of Medical Officer was not available at Sub District Hospital, Tiroda.

3. Thereafter, request was made by the applicant to post her at Rajegaon on the ground that she has to look after her newly born baby

but nothing was done. Consequently, respondents were directed not to fill in post at Rajegaon till further order. Respondents thereafter issued order and gave temporary posting to the applicant at Devri. The applicant obeyed that direction under hope that she would be posted at least at Rajegaon but no action was taken.

4. On perusal of the transfer order dated 19-07-2019, it seems that against the name of the applicant there was noting that after the date of transfer order of applicant to Tiroda this order could remain stayed for a period of 2 months and thereafter she would have to resume the duty at Tiroda. Under these circumstances, it was obligatory to the Medical Superintendent to allow her to resume at Tiroda but it was not done.

5. Since October, 2019 it is informed by the respondents that proposal is made for transferring the applicant and it was pending before the Hon'ble Minister, Public Health, Department for the reason that there was Code of Conduct operating in view of the elections. It is pertinent to note that even thereafter also even after the election there was ample time and opportunity but no steps are taken by the respondents to decide this controversy. Today also copy of the same letter is placed before the

Bench after changing the date of letter stating that till today proposal is not granted by the Hon'ble Chief Minister. In this matter, the applicant is suffering without there being any fault on her part.

6. As a matter of fact, when the applicant was transferred to Tiroda, there was no reason to modify the order and post another Medical Officer i.e. respondent no.4 after cancelling the transfer to Gadchiroli at Tiroda. All these circumstances are sufficient to show the conduct is *mala fide* and only to accommodate the respondent no.4.

7. In this situation, respondent nos.1 to 3 are directed to post the applicant at Rural Hospital, Rajegaon, Dist. Gondia and report the compliance within 2 weeks. O.A. stands disposed of with no order as to costs.
