We have perused para-6 of the order in O.A. 356/2015 wherein the specific direction was given to the respondent no.2, the Collector and Chairman, District Selection Committee, Amravati to conduct the inquiry in view of the observations made in para-5 of the order. On perusal of the report submitted by the Sub Divisional Officer, Amravati, it seems that without considering the directions, the inquiry was conducted and mechanically report was prepared.

3. We have perused the findings on issue no.3. It is observed by the Sub Divisional Officer, Amravati that the disputed documents were required to be examined from the expert, but disputed documents were not forwarded to him, therefore, he was unable to conduct the inquiry. In this regard, we would like to point out that it was duty of the Sub Divisional Officer who was conducting the inquiry as per the judicial

direction to report this matter to the Collector, Amravati and to call the disputed documents for verification of the facts whether the said certificate was genuine or it was fabricated. In view of this, we are compelled to say it was mere farce of the inquiry and it was not fair inquiry. We further say that mechanically report was submitted and the direction issued in O.A. 356/2015 not complied. In this situation, we direct the respondent no.2 to personally conduct the inquiry within a period of two months from the date of this order after reading the para nos. 5&6 of the order in O.A.No.356/2015.

2. The Applicant is challenging the impugned order of transfer dated 31st May, 2019. The Applicant is transferred from Gosekhurd Lift Irrigation Division (Ambadi), Bhandara to Bagh Itiyadoh, District Gondia on vacant post. The Id. Counsel for the Applicant submitted that the Applicant is posted on a vacant place. It was lying vacant for years, the post is lapsed, and therefore, the transfer order is illegal. There is no dispute about the fact that the Applicant was overdue for transfer, as he was working at Gosekhurd, Bhandara since 2008. The provision under Section of the Transfer Act is very much clear which says that after completion of two normal tenures, the Government servant shall be transferred.

3. I do not see any merit in the contention of the Applicant that the Applicant is posted on vacant post which is lapsed. As the Applicant is posted on vacant post, it was the responsibility of the Government to pay his salary and to create a post for him. It seems that the Applicant never attempted to

resume duty as per the transfer order. It is not a case that the Applicant had gone to Itiyadoh to join his duty and he was sent back for reason that there was no sanctioned post to accommodate the Applicant. Under the circumstances, I do not see any merit in the transfer application.

4. The Id. Counsel for the Applicant submitted that the Applicant would resume duty but he should be adjusted for two months at Gosekhurd, Bhandara. It appears from the facts and circumstances of the case that when the matter was came up for the first time before the Bench, the order was passed on 8th July, 2019 that there was no *prima-facie* case to grant interim relief. In this situation, it was incumbent on the Applicant to resume duty promptly at the transferred station, but it is not done. It seems that the options vide Annexure 'A-16' were given by the Applicant for his transfer and Itiyadoh was given as a choice posting No.1 by the Applicant. As this choice posting was given by the Applicant, now the Applicant has no legal right to contend that his transfer at Itiyadoh is illegal. However, in the interest of justice, liberty is given to the Applicant to make representation to the Respondents to post him at convenient station. The representation of the Applicant be considered at the time of general transfers of the year 2020. No other relief can be granted to the Applicant.
