2. In these O.As. the applicants are appointed in service on compassionate grounds. The learned counsel for the applicants submitted that unless rules and policy of the State Government specifically provides that reservation policy is applicable to compassionate appointments, there cannot be presumption that compassionate appointment would be subject to validation of the caste claim only because the candidates belong to S.C. or S.T. category.

3. It is grievance of the applicants that vide impugned order dated 27/12/2019 issue is raised by the respondents that the applicants who are appointed on the post reserved for S.T. and the applicant does not possess caste scrutiny certificate issued by the Caste Scrutiny Committee and for this reason, the order dated 27/12/2019 is passed and fresh appointment for 11 months is now given to the applicants.

4. It seems that the order impugned is issued by the Government on the basis of the G.R. dated 21/12/2019. As the applicants are initially appointed on compassionate ground, therefore, in view of the ratio in case of **Ajinky S/o Rajiv Khadatkar Vs. M.D., Maharashtra State Electricity Distribution Co. Ltd., Prakashgad & Ors., 2019 (2) Mh.L.J.,654.**, the case has merit and therefore we stay the effect and operation of the order dated 27/12/2019 till filing of the reply by the respondents.
