
No.MAT.1096/429/(58)-IX.- In exercise of the powers conferred by sub-section (1) of section 18 of the Administrative Tribunals Act, 1985 (13 of 1985), the Government of Maharashtra hereby directs that, the jurisdiction of the Aurangabad Bench of the Maharashtra Administrative Tribunal, shall extend to the Dhule district of the Nashik Revenue Division and the said Bench shall exercise jurisdiction, powers and authority in all matters arising out of Dhule district under the said Act; and for that purpose amends the Government Notification, Law and Judiciary Department, No.541,105/1878(90)-XI, dated the 14th August 1992, as follows, namely:-

In the schedule to the said notification,-

(a) against entry at serial No.1, in column 3, for the brackets and words "(except Ahmednagar and Jalgaon District)" the brackets and words "(except Ahmednagar, Jalgaon and Dhule District)" shall be substituted;

(b) against entry at serial No.3 in column 3 for the words "Ahmednagar and Jalgaon" the words "Ahmednagar, Jalgaon and Dhule" shall be substituted
