- ii) The Index, synopsis, list of annexure shall not be in continuation of the Pleadings/petitions/submissions/affidavits but it shall start on separate paper with printing on both sides of the paper.
- iii) Each document/annexure filed along with the Pleadings/petitions/submissions/affidavits shall start on separate page with document/annexure number, with proper margin as mentioned in point No. (i).
- iv) If the petition/submission/affidavit/documents pertain to division bench, two sets shall be provided together at the time of filing itself.
